

Equipment Supplied for Trial and Evaluation - Terms & Conditions

This Trial Equipment Agreement, dated as of the date set forth below, between **M.I.Data Solutions Ltd.** and <u>*Customer*</u> sets forth the terms and conditions for the loan of <u>*Trial Equipment (see Annex A)*</u> by M.I.Data Solutions Ltd to <u>*Customer*</u> for the sole purpose of trial and evaluation of the said Equipment. <u>*Customer*</u> hereby agrees that such Equipment loan shall be subject to the following terms and conditions:

TERMS AND CONDITIONS

1. M.I.Data Solutions Ltd supplies the equipment *(see Annex A) on a "sale or return" basis and will invoice <u>Customer</u> for the Equipment at the price(s) in effect at the time of shipment. All prices are F.O.B, ACD Achstetten and <u>Customer</u> is responsible for <u>inbound and return freight charges in advance</u> (see note 3e). The invoice will include a description of the Equipment with a caption "TRIAL EQUIPMENT" noted on the invoice and will be dated as of shipment date. <u>Customer</u> may use the Equipment for trial and evaluation for a period of <u>30 days</u> from the invoice date. If the Equipment is returned to M.I.Data Solutions Ltd. immediately after the agreed <u>30 day</u> period, <u>Customer</u> will be credited for the invoiced amount of the Equipment returned. If the Equipment is <u>not</u> returned to M.I.Data Solutions Ltd. immediately after the equipment invoice amount per month until the equipment is returned.

2. <u>Customer</u> has 4 business days from receipt of the equipment to verify working condition. If the equipment is not in working condition, <u>Customer</u> will notify M.I.Data Solutions Ltd. and request/obtain a return authorization number and return the equipment immediately for credit. If notice is not given within 4 business days, equipment shall be deemed to be in full working order.

3. Equipment returned to M.I.Data Solutions Ltd. ***(see Annex A)** must be in the same working and physical condition as it was at the time the Equipment was delivered by M.I.Data Solutions Ltd. to the carrier. To avoid the return being rejected, the following criteria must be met:

a) You must use the original packaging, if provided, both inside and outside.

b) All returns must be complete with all manuals, cables, warranty cards, etc, just as you received them.

c) Product must be clean and without scratches or usage marks of any kind. Please do not put labels on or write on the product.

d) If the Equipment is not returned in such condition, in addition to any other amounts owing to M.I.Data Solutions Ltd, *Customer* will be liable to M.I.Data Solutions Ltd. for the amount necessary to restore the Equipment to such condition, or if not so restorable, the value of the invoice amount, as determined by M.I.Data Solutions Ltd. at its sole discretion. *Customer* may purchase the Equipment "AS IS" at the invoice amount in lieu of paying such repair cost and any late service charges, if applicable. The invoice amount will be paid to M.I.Data Solutions Ltd. within <u>30 days</u> of *Customer* receipt of notification from M.I.Data Solutions Ltd. of such repair cost.

e) Return shipping cost will be refunded by M.I.Data Solutions Ltd. should *Customer* decide to retain the product.

4. All invoice amounts are subject to VAT at the prevailing rate.
